**If you wish to take a complaint about prison conditions and / or the fairness of the trial to a higher level, you will need to seek advice from a specialist organisation. In most cases, you will need to have exhausted the legal process in the country of detention first. It is important to note that there may be time limits involved. This factsheet lists some of the organisations you may wish to contact.**

The FCO Pro Bono Lawyers Panel was established to help promote and protect the human rights of British nationals overseas. The Panel functions by providing legal expertise and advice to British nationals facing legal proceedings overseas where there are human rights concerns. Lawyers from the Panel work in conjunction with a local lawyer; they do not replace them. If you think your case fits the above criteria, and believe the Panel may be able to assist you and your local lawyer, you should contact either the nearest British Embassy/Consulate/High Commission, or the Pro Bono Lawyers Panel at the above address. The FCO will then consider your case, and determine whether or not it is appropriate to refer it to the Panel.

Fair Trials International seeks justice and fair legal representation for people detained outside their country of residence. They provide legal advice and assistance to people who feel they have been unfairly arrested or tried in foreign countries. They try to help avoid potential miscarriages of justice and assist with pardons if it can be established that a breach of legal rights has occurred. FTI does not charge any fees for its services. If FTI makes referrals to other lawyers or firms, these may charge a fee.

## **The AIRE Centre (Advice on Individual Rights in Europe)**

The AIRE Centre has a team of multi-lingual specialist international lawyers providing advice, information and a representation service covering all aspects of individual rights in Europe under international law. It provides information relating to prisoners' rights and other fundamental freedoms and human rights but does not advise on any individual country's legal system. They do not charge fees. The AIRE Centre cannot assist in cases outside of Europe. NB the AIRE Centre only accepts cases by referral through a legal representative. If you think that the AIRE Centre could help you, ask your lawyer to contact the AIRE Centre directly or talk to the casework team at Prisoners Abroad.
